Jockey **Alejandro Medellin** having been summoned and appeared before the Ruidoso Downs Board of Stewards on August 6, 2023, for striking a rival horse in the head, while aboard "I Get Stormed" in the 9th race on August 5, 2023, at Ruidoso Downs Racetrack, resulting in the disqualification of his mount from 2nd to 3rd.

For this violation, the Board of Stewards hereby assess <u>Alejandro Medellin</u> a suspension of <u>3 race</u> <u>days (August 13, 18, 19, 2023).</u> The term of this suspension shall <u>not</u> prohibit participation in designated races.

#### Licensee is found to be in violation of:
