Ruling:

Trainer Alfredo Gomez having been duly notified and having failed appear, had his hearing held in absentia, in accordance with 15.2.1.9(B)(4)(d) non-appearance, before the Board of Stewards at Ruidoso Downs on August 25, 2023. The hearing was regarding a lab report from Industrial Laboratories (the Official testing laboratory for the NMRC) to the confirmed positive of the drug 3-hydroxylidocaine at 36.9 pg/mL, Class 2 Penalty B, found in the blood of test sample E630769 taken from the horse "HS Hawk" the 2nd place finisher in the 3rd race on July 15, 2023, at Ruidoso Downs Racetrack in Ruidoso Downs, NM.

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer and declined.

The Owner for the horse "HS Hawk" at the time of the violation was Humbaldo Solis.

Note: Neither witnesses nor evidence were presented to disprove the findings of the New Mexico Racing Commission.

For **Alfredo Gomez** first Class 2 Penalty B medication violation in a 365 Days the Board of Stewards hereby assess a penalty, issued in accordance with 15.2.6.9 (B)(1) Penalty Recommendations, as follows:

- 1) A fifteen (15) day suspension, beginning August 25, 2023 through and inclusive of September 8, 2023.
- 2) A fine of five hundred dollars (\$500.00), fine to be paid on or before Sunday, September 24, 2023, in accordance with 15.2.3.8 (B)(3)(l) NMAC. Failure to pay a fine in prescribed time will result in an immediate suspension.
- 3) In addition, Alfredo Gomez has accumulated "0" points prior to this ruling and "2" points in connection with this ruling for a current total of "2" under the multiple medication violation point system.

In accordance with 15.2.1.9 (C)(21), **Alfredo Gomez** is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of **Alfredo Gomez** are ineligible to be entered or start in any

For **Humbaldo Solis** 1st Class 2 B medication violation in a 365 Days the Board of Stewards hereby assess a penalty, issued in accordance with 15.2.6.9 (B)(1) Penalty Recommendations, as follows:

- 1) The horse "HS Hawk" is hereby disqualified from 2nd place and ordered unplaced from the 3rd race on July 15, 2023, at Ruidoso Downs Racetrack for all but parimutuel wagering.
- 2) The horse "HS Hawk" must pass a commission approved examination before being eligible to enter.

Trainer Juan M. Gonzalez is hereby summarily suspended, effective immediately August 25, 2023, pending the outcome of his summary suspension hearing scheduled on September 2, 2023 at 9:00 A.M. in the offices of the Board of Stewards at Ruidoso Downs Racetrack (26225 US Highway 70, Ruidoso Downs, NM 88346) per 15.2.1.9 (B)(3)(b) (Summary Suspension) regarding Juan M. Gonzalez being found in possession of a hypodermic needle and syringe, located in the pocket of a jacket, hanging in his barn on August 25, 2023. During said time of applicable suspension, Juan M. Gonzalez is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, per 15.2.1.9 (C)(21) (a-b) Exclusion.

Licensee is found in violation of and this ruling is written in accordance with: 15.2.1.9(B)(3)(a) Proceedings Before The Stewards: Summary Suspension If the Stewards determine that a licensee's action constitute an immediate danger to the public health, safety, or welfare, the Stewards may summarily suspend the licensee pending a hearing. 15.2.1.9(B)(3)(b) Proceedings Before The Stewards: Summary Suspension A licensee whose license has been summarily suspended is entitled to a hearing on the summary suspension not later than the 10th day after the license was summarily suspended. Trainer Jesus Rondan Jr. having been duly notified and waved his 10-day notice and formal hearing, via telephone, before the Board of Stewards on August 28th, 2023, for entering the horse "Dont Be a Karen" to run at two different tracks (The Downs at Albuquerque & Ruidoso Downs Racetrack) on the same day (entered on August 27, 2023 for race day September 3, 2023) and necessitating a late scratch for the 2nd race on September 3, 2023, at Ruidoso Downs Racetrack.

The Board of Stewards hereby assess penalty as follows:

1. For this rule violation, the Board of Stewards assessed Jesus Rondan Jr a penalty in the amount of Five Hundred Dollars (\$500.00). The fine is to be paid on or before October 2, 2023, in accordance with 15.2.3.8(B)(3)(l) NMAC. Failure to pay the fine within the time prescribed will result in immediate suspension.
