Ruling:

Jockey, <u>Santiago Gonzalez</u>, having been summoned and having appeared before the Board of Stewards on <u>October 1, 2023</u>, for careless riding during the running of the <u>6th race on September 30, 2023, at The Downs at Albuquerque Racetrack</u>, while aboard 'Magic Is Flying'. (Drifted into the path of #7 Golden Merger causing to check and interfering with #6 Tale of truth making the horse to check also.

For this violation, the Board of Stewards assessed <u>Santiago Gonzalez</u>, a 3-day racing suspension, October 11th, October 13 th, & October 14th, 2023. <u>Santiago Gonzalez</u>, may ride in designated races.

### Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(a) NMAC: Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."
