Jockey, <u>Santiago Gonzalez</u>, having been summoned and having appeared before the Board of Stewards on <u>October 25, 2023</u>, for careless riding during the running of the <u>10th race on October 22</u>, <u>2023</u>, <u>at The Downs at Albuquerque</u>, while aboard <u>"Wealth N Health"</u>. (Drifted out down the stretch, into the path of #8 Coming Abstraction, causing #8 to check and alter course causing a better placement. <u>Wealth N Health</u> was DQ from 1st and placed 2nd.

For this violation, the Board of Stewards assessed <u>Santiago Gonzalez</u> a 3-day racing suspension, November 3rd, November 4th, and November 5th, <u>Santiago Gonzalez</u> may ride in designated races.

Jockey Reyes Gomez having been summoned and appeared telephonically before the Board of Stewards on October 28, 2023, for failure to honor or be excused from his riding engagement on Friday October 27, 2023, in the 8th race, at Downs at Albuquerque Racetrack. (#9 Ducheck Jqm).

For this violation, the Board or Stewards assessed, Reyes Gomez a fine in the amount of Two Hundred and Fifty dollars, \$250.00. The fine is to be paid on or before November 27, 2023, in accordance with 15.2.3.8 (B) (3) (1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13 (C)(1) (3) Jockey requirements: (1) Jockeys shall report to the jockeys' quarters at the time designated by the association. Jockeys shall report their engagements and any overweight to the clerk of scales. Jockeys shall not leave the jockeys' quarters, except to ride in scheduled races, until all their riding engagements of the day have been fulfilled except as approved by the stewards (3) Except as otherwise provided by this subsection, a jockey engaged for a certain race or for a specified time may not fail or refuse to abide by the engagement agreement, unless excused by the stewards. Failure to fulfill riding engagements may result in disciplinary action.

Jockey Enrique Garcia, having been summoned and had Daniel Vergara represent him before the Board of Stewards on October 29, 2023, for excessive use of whip, while aboard "Big League Benny" in the 4th Race October 27, 2023, at Downs at Albuquerque, is found to be in violation of Commission rules (hitting his mount 20 times).

For this violation, the Board of Stewards assessed Jockey, a fine in the amount of Enrique Garcia One Thousand Dollars. (\$1000.00). This fine is to be paid on or before November 28, 2023, in accordance with 15.2.3.8 (B)(3)(1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop, or striking another rider or horse.
