Trainer Alberto Amparan having been duly notified and waived his 10-day notice and formal hearing before the Board of Stewards on October 31, 2023, for failure to have at least two approved workouts within sixty (60) days prior to the time of entry on the horse "Brookstone" in the 5th race on November 3, 2023, necessitating a late scratch at Zia Park Racetrack.

The Board of Stewards hereby assesses penalty as follows:

1.A fine of Two Hundred Fifty Dollars (\$250.00) which must be paid on or before November 30, 2023.

Licensee is found to be in violation of and this ruling is written in accordance with

15.2.5.11 (A)(2) Workout Requirements: Any horse which has started, but not within 60 days, must have at least one workout within 60 days prior to the time of entry. Horses that have not started within six months of entry must have at least two approved workouts within the 60 days prior to time of entry.

(17) representing an owner in making entries and scratches and in all other matters pertaining to racing; horses entered as to eligibility and weight, or other allowances claimed.

Jockey Christian Reyes, having been summoned and appeared before the Board of Stewards on November 4, 2023, for excessive use of whip, while aboard "Eb Katrina in the 3rd Race October 29, 2023, at Downs at Albuquerque, is found to be in violation of Commission rules.

For this violation (first offense), the Board of Stewards assessed Jockey Christian Reyes, a fine in the amount of Five Hundred Dollars. (\$500.00). This fine is to be paid on or before November 29, 2023, in accordance with 15.2.3.8 (B)(3)(1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.
