Jockey Jose Enriquez, having been summoned and having appeared before the Board of Stewards on November 26, 2023, for careless riding during the running of the 1st race on November 25, 2023, at Zia Park Racetrack, while aboard 'Wheels Up Bb". (After the break mid-way down the stretch started to drift in shutting off #1 making the #1 rider take up and alter course warranting a DQ of this mount. At that time Jose Enriquez did not try to straighten his mount.

For this violation, the Board of Stewards assessed Jose Enriquez seven (7) day suspension -12/03/2023 - 12/10/2023. Can ride designated race days.

Licensee is found in violation of:

Jockey Daniel Torres, having been summoned and having appeared before the Board of Stewards on November 26, 2023, for careless riding during the running of the 1st race on November 19, 2023, at Zia Park Racetrack, while aboard 'El Buenas Noches". (After the break going into the turn put pressure on the #1 and then mid-way down the stretch drifted in under right handed whip causing interference to the inside horses.

For this violation, the Board of Stewards assessed Daniel Torres three (7) day suspension -12/03/2023 - 12/10/2023. Can ride designated race days.
