RE: 2024-SUN-12 - Ruling Final Outcome

Owner **Kristi Martinez (a minor child)** was duly notified represented by her mother, **Allison Martinez and Gene Chavez** who appeared via Teams video conference before the Sunland Park Board of Stewards on **February 21, 2024. The hearing was in regards certificate of analysis from Industrial Laboratories (The official testing laboratory for the NMRC)**, for a confirmed positive for the controlled substance and prohibited drug "Albuterol" (a class 3 Penalty A drug) detected in the urine of horse "Papalotes Vike" found "Test sample **E626108**" which finished **1st place finisher in the 3rd race on October 25, 2023 at The Downs at Albuquerque. The drug Albuterol was confirmed in the split sample which was sent to PA Equine Toxicology & Research Laboratory.**

**Allision Martinez, the trainer of record for horse "Papalotes Vike" and representative of owner Kristi Martinez, was duly notified regarding the testing results. This is owner Kristi Martinez's first class 3A medication violation in a 365-day period.**

For **Kristi Martinez's** first Class 3A medication violation in 365-day period, the board of stewards, in accordance with 15.2.6.9(B)(2) (Penalty Recommendations) hereby assess the following penalties:

Pursuant to Rules 15.2.3.8(B)(9)(a)(e), Stewards List, 15.2.6.9(C)(8)(c) Positive test breport, 15.2.6.9(C)(9) Positive Test List, 15.2.6.9(C)(10)(a-d), List Removal Requirements, the horse "**Papalotes Vike**" shall be placed on the veterinarian's list for **180 days, beginning October 18, 2023, through April 15, 2024.** During that time period, the papers for "**Papalotes Vike**" are to be removed from the racing office and the horse denied entry until passes a Commission-approved veterinary examination.

In accordance with Rule 15.2.5.13€(4)(d) Purse Redistribution, the horse "**Papalotes Vike**", is hereby disqualified from 1st place and ordered disqualified from the **3rd Race on October 25, 2023 at The Downs at Albuquerque** for all but pari-mutuel wagering.
