Jockey Juan Carlos Villanueva opted to waive his summary suspension hearing, 10-day notice, and disciplinary hearing before the board of stewards of Sunland Park Racetrack on February 10,2024 at 10:00am in this matter. Failing a drug test which was positive for THC.

The Board of Stewards determined mitigating/Aggravating factors:

• First Offense

The Board of Stewards hereby assesses a penalty as follows:

1. A 15-day (Fifteen) suspension beginning February 4, 2024, through February 19.

In accordance with 15.2.1.9 (C)(21), Jockey Juan Carlos Villanueva is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Before being reinstated must pass a drug test on or after February 19,2024.

Licensee is found in violation and this ruling is written in accordance with:

16.47.1.17 (A)(1) TESTING PROCEDURES At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the racetrack.

16.47.1.17 (A)(2) TESTING PROCEDURES When conducted, random drug testing shall apply. equally, to all licensees who are, at the time of the random testing, exercising the privileges of their license in such ways as may affect the outcome of a race or diminish the conditions of safety or decorum required in restricted areas.

on reasonable suspicion that the person is using drugs or alcohol or is based 16.47.1.17 (C)(6) Human Drug Testing/Restricted Activities It shall be an offense to exercise the privileges granted by a license from this commission if the licensee: refuses to submit to urine or drug testing, when notified that such testing is based on a random drug testing procedure. is based on the licensee's acting as if in an impaired condition.

Appeal Procedures An appeal under this section must be filed not later than 10 days after the date of the ruling. If the deadline falls on a Saturday, Sunday or legal holiday, the period is extended to include the next day that is not a Saturday, Sunday or legal holiday. The appeal must be received by noon, at the main commission offices or with the stewards who issued the ruling and must be accompanied by a fee in the amount of \$400. The fee must be in the form of a money order, cashier's check or a corporate check. Last day to appeal March 20, 2024.

By Order of The Sunland Park Stewards
