Jockey, Matias Bravo, having been summoned and having appeared before the Board of Stewards on January 12, 2024, for careless riding during the running of the 7th race on January 11, 2024, at Sunland Park Racetrack, while aboard "Found My Ball". Mr. Matias Brave allowed his mount to drop over into the path of # 5 Secret Potion and #6 Capital Joke causing the 2 riders to check their mounts. At the top of the stretch jockey Matias Bravo let his mount go from the middle of the track to the inside not steering his mount only flagging his mount right-handed not controlling his mount. (This is Matias Bravo 1st offence in New Mexico. )

For this violation, the Board of Stewards assessed Matias Bravo, a 3-day racing suspension, January 19th-25th & 26th. Matias Bravo may ride in designated races.

<u>Armando Quintanilla Jr</u> was properly notified in accordance with 15.2.6.9 J (1) (a-e) OUT OF COMPETITION TESTING.

The Board of Stewards hereby access Armando Quintanilla Jr:

A penalty of One and a Half year(1.5) suspension of all NMRC licenses starting <u>January 14, 2024</u>, <u>through July 14,2025</u>, inclusive.

The horses "<u>Alebrije</u>", "<u>Discodancinpatriot</u>" and "Mariel" are placed on the stewards list for a minimum of 120 days beginning 12/7/23 through 4/5/2024. These horses must pass a hair test before entry. May test on or after 4/5/2024.

Aggravating factors

1. Did not call or try to get in touch with the commission saying he did not have position of the horses.

2. Papers were still on file in his name in the racing office at Zia Park Racetrack.

Mitigating Factors :

1-Past record has not had a ruling since 2018.

During said time of applicable suspension Armando Quintanilla Jr is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC, in accordance with 15.2.1.9 (C)(21)(a-b). Additionally, effective upon applicable suspension dates, all horses owned or trained, or under the care of Armando Quintanilla Jr are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c).

Jockey Francisco Glies, having been summoned and appeared before the Board of Stewards on January 14, 2024, for excessive use of whip, while aboard "Jm Johnny B Good. in the 6th Race January 13, 2024, at Sunland Park Racetrack, is found to be in violation of Commission rules.

For this violation (first offense of 2024), the Board of Stewards assessed Jockey Francisco Glies a fine in the amount of Five Hundred Dollars. (\$500.00). This fine is to be paid on or before February 14, 2024, in accordance with 15.2.3.8 (B)(3)(1) . Failure to pay the fine within the time prescribed shall result in immediate suspension.

Aggravating Factors: Failure to guard.

1)Second medication violation in 365 days.

2) Did not show up for hearing.

Mitigating Factors: 1) None

Split Sample rights were afforded to the trainer. Split Sample E625994 was submitted to UC Davis at the request of the trainer and was confirmed positive for Clenbuterol.

Arnulfo Ascencio Jr is the trainer of record for "Streakin Big Daddy".

After hearing the facts of the case and testimony, and considering all Mitigating and Aggravating factors the Sunland Park Board of Stewards determined the following:

1) Mr. Arnulfo Ascencio Jr is hereby fined \$50,000.00 (Fifty Thousand). Fine to be paid on or before Janurary27th, 2024, in accordance with 15.2.1.9 (B)(7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

2) A suspension of Five (5) years. The term will run consecutively with his 1-year suspension (2023-DAA-56) this suspension will start October 19, 2024, through October 18, 2029.

3) In addition, Arnulfo Ascencio Jr had accumulated "6" points prior to this ruling and "6" points in connection with this ruling for a current total of "12"- points, under the multiple medication violation point system.

4) Mr. Arnulfo Ascencio gets an additional 360 days.(October 19.2029 through October 14.2030 5) Mr. Arnulfo Ascencio Jr must take a written trainers test once he has served his penalty.

Owner Jesus Arroyo was duly notified and appeared via teams zoom before the Board of Stewards on January 17, 2024. The hearing was in regard to a certificate of analysis from Industrial Laboratories (official testing laboratory for the NMRC) for a confirmed positive for the controlled substance and prohibited drug (class 3 penalty A) "clenbuterol" detected in the Blood of horse "Streakin big Daddy" (Test Sample #: E625994). who finished 2nd place in the 3rd race on October 4, 2023, at the Downs at Albuquerque. The drug clenbuterol was confirmed in the blood of the split sample sent to UC Davis.

Arnulfo Ascencio Jr, the trainer of record for horse "Streakin big Daddy "Jesus Arroyo, was duly notified. This is Jesus Arroyo FIRST Class 3A medication violation in a 365-day period.
