RE: 2024-SUN-90 - Ruling Final Outcome

Jockey Mr. Jaime Parga-Leos having been summarily suspended on March 16, 2024, per ruling 2024-Sun-90. Mr. Parga Leos was properly notified for his disciplinary hearing on April 13, 2024, held before the Board of Stewards at Sunray Park. The hearing was in regard to Mr. Parga-Leos testing positive for cocaine in a field test taken on March 16, 2024, and sample being confirmed by the New Mexico Racing Commission laboratory, Cordant Health Services. See Rulings 2024-SUN-90.

## Aggravating Factors:

1. Second offense (see ruling 2017-RUI-150

2. Admitted during testimony to having used cocaine.

Mitigating factors: None

The following penalties are imposed upon Jaime Parga Leos:

1. A 1-year suspension of all NMRC licenses, retroactive from summary suspension ruling 2024-SUN-90, to run from March 16, 2024, through March 16, 2025, inclusive.

2. Mr. Parga-Leos shall undergo a formal assessment by an accredited New Mexico-based treatment facility dealing with drugs and alcohol addiction with a minimum 60 day in house treatment.

3. Prior to reinstatement, Mr. Parga-Leos must appear before the Board of Stewards with proof of completion of the aforementioned treatment program and supply a negative urinalysis.

During said time of applicable suspension Jaime Para Leos is hereby excluded from all areas of the under the jurisdiction of the NMSRC, per15.2.1.9 (C)(21) (a-b) Exclusion.

Licensee is found to be in violation of:

6.47.1.17 (A)(1) TESTING PROCEDURES At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the racetrack.

16.47.1.17 (A)(2) TESTING PROCEDURES When conducted, random drug testing shall apply, equally, to all licensees who are, at the time of the random testing, exercising the privileges of their license in such ways as may affect the outcome of a race or diminish the conditions of safety or decorum required in restricted areas.

16.47.1.17 (C)(6) Human Drug Testing/ Restricted Activities It shall be an offense to exercise the privileges granted by a license from this commission if the licensee: refuses to submit to urine or drug testing, when notified that such testing is based on a random drug testing procedure, is based on reasonable suspicion that the person is using drugs or alcohol or is based on the licensee's acting as if in an impaired condition.

16.47.1.8 (L)(1)(i) - CONDUCT Which states in pertinent part "The Commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures if the applicant is a person whose conduct or reputation may reflect on the honesty, and integrity of horse racing."

16.47.1.8(L)(I) - Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (I) is disrespectful or intimidates any official, commissioner, or commission staff or any other licensee;

During said time of applicable suspension Jaime Parga Leos is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC, per15.2.1.9 (C)(21) (a-b) Exclusion.
