Ruling:

Trainer, Guadalupe Munoz Jr., having been properly summoned and having appeared before the Sunland Park Board of Stewards on April 7, 2024, and having waived his right to a formal hearing for having an unlicensed person in his barn on Sunday March 31, 2024, on the premises of Sunland Park Racetrack.

For this violation:

Trainer, Guadalupe Munoz Jr., is hereby fined the sum of \$250. (Two Hundred Fifty Dollars)

Pursuant to 15.2.3.8 : B.(k) All fines imposed by the stewards shall be paid to the commission within 30 days after the ruling is issued, unless otherwise ordered. This fine is to be paid on or before May 7, 2024, in accordance with 15.2.3.8 (B)(3)(e)(i)(k). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

Trainer, Guadalupe Munoz Jr., having been properly summoned and having appeared before the Sunland Park Board of Stewards on April 7, 2024, having waived his right to a formal hearing for being in possession of prescription medications which were improperly labeled and a controlled substance which were found in his assigned barn resulting from a barn search conducted on Sunday March 31, 2024 at Sunland Park Racetrack

For these violations:

Trainer, Guadalupe Munoz Jr., is hereby fined the sum of \$750. (Seven Hundred Fifty Dollars) Pursuant to 15.2.3.8: B.(k) All fines imposed by the stewards shall be paid to the commission within 30 days after the ruling is issued, unless otherwise ordered. This fine is to be paid on or before May 7, 2024, in accordance with 15.2.3.8 (B)(3)(e)(i)(k). Failure to pay the fine in the prescribed time shall result in an immediate suspension.


