"Brannigan" in the 9th race on April 13,2024 which necessitated a late scratch at SunRay Park,

For this violation, the Board of Stewards assess the following penalty:

1.A fine in the amount of Five Hundred Dollars (\$500.00). The fine is to be paid on or before April 27, 2024. Failure to pay the fine within the prescribed time shall result in an immediate suspension. Pursuant to Rule 15.2.1.9 A(7)(f) NMAC. All fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise noted, in accordance with Rule 15.2.3.8 (B)(3)(e)(i),

Jockey Brian Cobos-Barraza, having been properly summoned and having appeared before the SunRay Park Board of Stewards on April 13, 2024, and having waived his right to a 10-day notice and formal disciplinary hearing for excessive use of whip causing multiple welts on the flank, while aboard "Buckie Jones" in the 7th Race April 12, 2024, at SunRay Park. Found to be in violation of Commission rules: Rule 15.2.5.13 E (8)(a)(9)(c).

The Sunray Park Board of Stewards hereby assess the following penalty:

1. A fine of One Thousand Dollars (\$1,000.00) and a 7 day suspension to be served from April 22, 2024 through April 28, 2024, in accordance with 15.2.3.8 (B)(3)(e)(i). This fine must be paid on or before April 28, 2024. Failure to pay the fine within the prescribed time shall result in an immediate suspension. All fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered. (Pursuant to Rule 15.2.1.9 A(7)(f) NMAC)

Mr. Barraza may ride in designated races.

Licensee is found to be in violation of this ruling which is written in accordance with: 15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse; on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.
