Trainer Armando Castellanos having been duly notified and having been appeared with interpreter Josa A. Gonzalez before the Sunray Park Board of Stewards (39 Road 5568 Farmington. NM 87401) for his summary suspension hearing on Friday, May 17th, 2024, at 11:00 am (15.2.1.9 (B)(3)(b) regarding the confirmed positive of the Class 3 penalty A drug, Albuterol, found in blood sample E546340 taken from third place finisher "Fly Through Winter" in the 2nd race on April 26, 2024, at Sunray Park Racetrack.

Split sample rights as provided in NMAD 15.2.6.10 (D) were afforded to and accepted by trainer Armando Castellanos and owner Jacob M. Tafoya.

Mr. Castellanos remains summarily suspended pending the outcome of split sample results.

There is no permissible concentration of Albuterol allowed to appear in any official sample. In accordance with 15.2.1.9 (C)(21), Armando Castellanos is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Armando Castellanos are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21) All transfers and sales of horses trained, owned, or in the care and custody of Armando Castellanos must be done in accordance with 15.2.6.9A(12)(a)(b) Medication and Prohibited Substances, 16.47.1.10 (D)(5) Assistant Trainers and 15.2.1.9(B)(8)(b) DUE PROCESS AND DISCIPLINARY ACTION.
