Jockey Jorge Carreno having been properly noticed and having appeared before the SunRay Park Board of Stewards on May 2, 2024, for failure to coduct his business in a proper manner by failing to notify the stewards of his absence, which necessitated a late rider change on "Princess Kitten" for the 9th race at SunRay Park on April 26, 2024

#### Licensee is found to be in violation of:

15.2.5.13 (C)(1) (3) Jockey requirements: (1) Jockeys shall report to the jockeys' quarters at the time designated by the association. Jockeys shall report their engagements and any overweight to the clerk of scales. Jockeys shall not leave the jockeys' quarters, except to ride in scheduled races, until all their riding engagements of the day have been fulfilled except as approved by the stewards. (3) Except as otherwise provided by this subsection, a jockey engaged for a certain race or for a specified time may not fail or refuse to abide by the engagement agreement, unless excused by the stewards. Failure to fulfill riding engagements may result in disciplinary action.

#### For this violation:

The SunRay Park Board or Stewards hereby assess the following penalty:

A fine of Two Hundred Fifty Dollars (\$250.00), which must be paid on or before May 16, 2024, in accordance with NMAC 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the time prescribed time may result in immediate suspension. Pursuant to NMAC Rule 15.2.1.9. (A)(7)(f) all fines imposed by the Stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

Owner Juan M Garcia, having been duly notified and having failed to appear, had his hearing held in absentia, in accordance with 15.2.1.9(B)(4)(d) non-appearance before SunRay Park Racetrack Board of Stewards (39 Road 5568 Farmington NM 87401) on May 2, 2024 at 10.00 am for a formal hearing. regarding a lab report from Industrial Laboratories (the Official testing laboratory for the NMRC) for a confirmed positive for the drug Clenbuterol, found in the urine sample for (Class 3 penalty A) found in test sample E493437 taken from the horse "One Fearless Eagle" who competed in the 1st race and finished 3rd on December 2nd, 2023, at Zia Park Racetrack, Hobbs, New Mexico.

Gaston Valenzuela is the trainer of record for the horse "One Fearless Eagle."

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the owner and trainer and was confirmed positive, in urine for Clenbuterol, by UC Davis Labratories. Sacremento, California.

Jockey Sergio Dominguez, having been summoned and having been represented by Jockey Gerardo Vera appeared before the Sunray Park Board of Stewards on May 4, 2024, for excessive use of whip. while aboard "Moon Spot" in the 12th race April 26, 2024, at Sunray Park, is found to be in violation of Commission rules. NMAC 15.2.5.13 (E)(9)(a)(b)

For this violation (third offense of 2024), the Sunray Park Board of Stewards hereby assess Jockey Sergio Dominguez a seven-day (7) suspension starting May 11, 2024, through May 17,2024, in accordance with Rule 15.2.3.8 (B)(3)(l). Mr. Sergio Dominguez may ride in designated races.

#### Licensee is found to be in violation of:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse: excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.

15.2.1.9(B)(4)(A)NMAC Notice Except as provided by these rules regarding summary suspension. jockey riding infractions and trial races, the stewards or a racing commission designee shall provide written notice, at least 10 days before the hearing, to a person who is the subject of a disciplinary hearing.
