RE: 2024-RUI-3 - Modified Ruling

Jockey Omar Iturralde having been duly notified and having been represented by Jockey Gerardo Vera appeared before the Ruidoso Downs Board of Stewards at 10:00 A.M. on May 25, 2024, for careless riding during the running of the 10th race on May 24, 2024, at Ruidoso Downs, while aboard #3 "Into Celebrating".

For this violation, the Board of Stewards issued the following penalty:

A 7- calendar day suspension, beginning on June 1,2024 and running through June 7, 2024. (Failed to make sufficient effort away from the starting gate to maintain his lane causing interference with outside horses)

Mr. Iturralde may ride in designated races during his suspension.

#### Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(a) NMAC: Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."

Jockey Ramiro Haro-Garcia having been duly notified and having appeared before the Ruidoso Downs Board of Stewards at 10:00 A.M. on May 26, 2024, for careless riding during the running of the 9th race on May 25, 2024, at Ruidoso Downs, while aboard #5 "Sea Train".

For this violation, the Board of Stewards issued the following penalty:

A 7- calendar day suspension, beginning on June 2, 2024 and running through June 8, 2024. (Failed to make sufficient effort away from the starting gate causing interference with #4 "Firstdown Junebug" which resulted in a disqualification from 4th to 7th place)

Mr.Ramiro Haro-Garcia may ride in designated races during his suspension.
