RE: 2024-SRP-10 - Modified Ruling

Assistant Starter Jesse Smith Duran summarily suspended, effective April 20, 2024, having failed a drug (urine) test on April 20, 2024, and having possession of drug paraphernalia at Sunray Park, per NMAC Rule (16.47.1.17 B(5)(7). A summary suspension hearing was held *in absentia on* April 27, 2024, before the Board of Stewards at SunRay Park. Jesse Smith Duran will remain suspended (per 15.2.1.9 (A)(3)(b) (Summary Suspension) *for being in possession of drug paraphernalia and pending the outcome of the urine analysis taken on April 20, 2024*. Jesse Smith Duran is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, per 15.2.1.9 (B)(21) (a-b) Exclusion.
