Owner Adrian Zapata, having been duly notified and having not appeared was represented by his trainer, Andres Gonzalez, via Teams before the Ruidoso Downs Board of Stewards, for his disciplinary hearing in the office of the Board of Stewards on Monday, June 3, 2024, at 9 a.m. This hearing is regarding a drug violation on March 2, 2024, at Sunland Park, involving the first-place finisher of the 8th race (The WEST TEXAS DERBY G3), "One Little Liar", for the drug 3hydroxylidocaine, a Class 2 Penalty B drug, found in blood sample #E545918, confirmed by Industrial Laboratories, the official lab of the NMRC, at 926 pg/mL +/- 2.9 pg/mL at the threshold of 20 pg/mL

Trainer Andres Gonzalez and owner Adrian Zapata were offered a split sample test and declined. Mr. Andres Gonzalez was the official trainer of record on March 2, 2024, for "One Little Liar". Mr Adrian Zapata was the official owner of record on March 2, 2024 for "One Little Liar".

In accordance with Rule 15.2.6.9(B)(4) PENALTY RECOMMENDATIONS, this is Owner Adrian Zapata first Class 2B medication violation in a 365-day period.

15.2.5.14 D. (7) Protests, Objections and Inquiries

Any award or prize given to Adrian Zapata for winning The WEST TEXAS DERBY G3 must be returned to the New Mexico Racing Commission for proper distribution.

The Ruidoso Downs Board of Stewards hereby issue the following penalty:

"One Little Liar" is hereby disqualified and unplaced for all but pari-mutuel wagering purposes. The horse "One Little Liar" must pass a commission approved examination before being eligible to enter.

Jockey Sergio Dominguez having been duly notified and having appeared before the Ruidoso Downs Board of Stewards on June 7, 2024, for careless riding during the running of the 10th race on June 2, 2024, at Ruidoso Downs, while aboard #7 "Rc Corona King".

For this violation, the Board of Stewards issued the following penalty:

A 7 - calendar day suspension, beginning on June 14, 2024, and running through June 20, 2024. (Failed to make sufficient effort away from the starting gate to maintain his lane causing interference with inside horses).

Mr. Sergio Dominguez may ride in designated races during his suspension.
