Jockey Rodrigo Sigala-Vallejo having been duly notified and having been represented by Jockey Christian Ramos appeared before the Ruidoso Downs Board of Stewards at 10:00 A.M. on May 27. 2024, for careless riding during the running of the 6th race on May 26, 2024, at Ruidoso Downs. while aboard #6 "Mr Cartel Jess".

For this violation, the Board of Stewards issued the following penalty:

A 7 - calendar day suspension, beginning on June 3, 2024, and running through June 9, 2024. (Failed to make sufficient effort away from the starting gate to maintain his lane causing interference with an outside horse).

Mr. Rodrigo Sigala-Vallejo may ride in designated races during his suspension.

Trainer Clinton Crawford having been duly notified and having responded by phone, waived his right to a 10-day notice and formal hearing before the Ruidoso Downs Board of Stewards on May 30. 2024, for failure to have a flipping halter on his entry "Woke Mob" for the 1st race on May 24, 2024, necessitating a late scratch and pari-mutuel refunds at Ruidoso Downs.

The Board of Stewards hereby issue the following penalty:

1.A fine of Five Hundred Dollars (\$500.00) which must be paid on or before June 13, 2024, In accordance with NMAC 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule NMAC 15.2.1.9 A(7)(f) all fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered

Ruling:

Jockey Jacob Enriquez having been duly notified and having appeared before the Ruidoso Downs Board of Stewards on June 1, 2024, for excessive use of whip, while aboard #1 "Mw I Am Your Patriot" in the 7th Race May 31, 2024, at Ruidoso Downs.

For this violation, the Board of Stewards issued the following:

1. A fine of Five Hundred Dollars (\$500.00) which must be paid on or before June 15, 2024, in accordance with 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the prescribed time shall result in an immediate suspension. Pursuant to Rule 15.2.1.9 (A)(7)(f) All fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

### Licensee is found to be in violation of NMAC:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.

This ruling is written in accordance with NMAC:

15.2.1.9(A)(4)(a) Notice Except as provided by these rules regarding summary suspension, jockey riding infractions and trial races, the stewards or a racing commission designee shall provide written notice, at least 10 days before the hearing, to a person who is the subject of a disciplinary hearing. The person may waive their right to 10 days notice by executing a written waiver.
