This hearing was to determine if Mr. Esquivel was the actual trainer of his horse "Chicks Comanchee", despite licensee Mr. David Hancock being listed as the trainer of record, and, if so, whether a penalty or other disciplinary action should be imposed upon Mr. Esquivel for such violation(s). The hearing involved the following Commission Rules and whether Mr. Esquivel has violated any such Rules:

This hearing was to determine if Mr. Hancock was engaged in a program training scheme to defraud the betting public, which would be detrimental to the honesty and integrity of the horseracing industry, in contravention to Commission Rules, regarding the horse "Our Daddys Girl", for which he was listed as the trainer of record during the Sunland Park race meet, and, if so, whether a penalty or other disciplinary action should be imposed upon him for such violation(s). The hearing involved the following Commission Rules and whether Mr. Hancock has violated any such Rules:

Basis for and Factors Relevant to Board of Stewards' Ruling:

The evidence revealed Mr. Hancock, the trainer of record for "Our Daddys Girl" during the Sunland Park race meet, was in fact engaged in a program training scheme which defrauded the betting public which was conduct detrimental to the honesty and integrity of the racing industry. Also, during the hearing, it was revealed Mr. Hancock made false or misleading statements to a Commission Investigator during her investigation of this matter. None of Mr. Hancock's statements to the Commission Investigator related to "Our Daddys Girl" comport with the documentary evidence presented in this matter.

Aggravating Factors:

1) Making false or misleading statements to a Commission Investigator during her investigation;

2) Failing to submit records of receipts of training or cost of training in response to a

Commission-issued subpoena to do so, and; 3) The horse "Our Daddys Girl" tested positive for a banned substance in OOCT.

Mitigating Factors: None

Penalties Imposed on Licensee:

After hearing the evidence and testimony presented, and considering all Aggravating factors, the NMRC Board of Stewards determines the following penalties be imposed:

1. Mr. David Hancock is hereby fined \$10,000 (Ten-Thousand Dollars) for the second offense of engaging in program training of the horse "Our Daddys Girl", a scheme to defraud the betting public and conduct detrimental to the honesty and integrity of the horseracing industry, and;

2. Mr. Hancock is hereby given a suspension of his NMRC license for a period of one (1) year commencing on February 5, 2026, through February 5, 2027. This suspension term will run

Mr. Amado Rivas is hereby fined \$5,000.00 (Five Thousand Dollars) for the Rule violation of the horse "Our Daddys Girl" being in the actual care, custody and control of an individual who is not currently licensed by the NMRC and/or is under current suspension, a program training scheme to defraud the betting public and which was detrimental to the honesty and integrity of the racing industry. 1. A fine of Five Hundred Dollars (\$500.00) which must be paid on or before September 1, 2024, in accordance with 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the prescribed time shall result in an immediate suspension. Pursuant to Rule 15.2.1.9 (A)(7)(f) All fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

Licensee is found to be in violation of NMAC:
