Jockey, Jose Enriquez, having been summoned and having appeared before the Ruidoso Board of Stewards, on July 19, 2024, for careless riding during the running of the 10th race on July 14, 2024, at Ruidoso Downs Racetrack, while aboard # 4 "Jess Dynasty Time" bore in sharply causing interference to inside horses.

For this violation, the Board of Stewards issued the following penalty:

A 7-calendar day suspension, beginning on July 26, 2024, through August 2, 2024.



Jockey, Jacob Enriquez, having been summoned and having appeared before the Ruidoso Board of Stewards, on July 19, 2024, for careless riding during the running of the 3rd race on July 14, 2024, at Ruidoso Downs Racetrack, while aboard # 5 "Agent Bob" who bore in sharply into the path of #4 "Thrillah" and #3 "Mr Prize Kvn" causing interference, costing both horses an opportunity at a better placing resulting in a disqualification of his mount. Agent Bob was dq'd from 8th place to 10th place.





