Trainer Juan Alfredo Hernandez appeared before the Board of Stewards at Sunray Park (39 Rd 5568, Farmington, NM 87401) for his summary suspension hearing, per Rule 15.2.1.9 (A)(3)(a), on April 24th, 2025, at 11:30 a.m. regarding the validity of an Equine Infectious Anemia Test Form (hereinafter "Coggins") and Equine Piroplasmosis Form (hereinafter "Piro") that was submitted to the Sunray Park Racing Office with the foal papers for the horse "Gallivant Ar". The foal certificate and Coggins/Piro was in Trainer Juan Alfredo Hernandez's file. Daniel Apodaca is listed as the Owner of "Gallivant Ar".

Jesus Antonio Apodaca-Diaz (Interpreter for and brother to Owner Daniel Apodaca) testified he wrote on both the United States Department of Agriculture (USDA) Coggins and the New Mexico Livestock Board Equine Piro. Jesus Antonio Apodaca-Diaz testified he wrote the name "Gallivant Ar" in the section for the horse's name on both the Coggins and Piro. The explanation provided by Jesus Antonio Apodaca-Diaz was that he felt the horse's name was blurry and not legible, so he wrote over the horse's name, and then made copies of both the Coggins and Piro, which he then gave to his brother, Daniel Apodaca, owner of "Gallivant Ar". Daniel Apodaca then submitted the altered copies to the Sunray Park Racing Office.

After viewing the evidence and testimony presented, the Sunray Park Board of Stewards hereby lifts the summary suspension for Juan Alfredo Hernandez effective April 24, 2025. A Board of Stewards disciplinary hearing for Mr. Hernandez will be scheduled after the completion of the investigations from both the USDA and the New Mexico Livestock Board.

The following horses shall remain on the Stewards list until the case is fully adjudicated: "Gallivant AR"; "Next Star"; "HS Apolos Light"; and "Nube Blancas".

NMAC 15.2.6.11(E)(2) Trainer Responsibility "having each horse in their care that is racing, or is stabled on association grounds, tested for equine infectious anemia (EIA) and for filing evidence of such negative test results with the racing secretary as required by the Commission;"
