Owner Jesus Antonio Apodaca-Diaz is hereby summarily suspended, effective April 24th, 2025, pending the outcome of his summary suspension hearing scheduled for April 30th, 2025, at 9:00 A.M. in the office of the Board of Stewards at SunRay Park (39 Rd 5568, Farmington, NM 87401) per Rule 15.2.1.9 (A)(3)(a)(b)(c) (Summary Suspension). The summary suspension is regarding admitting to altering the Coggins/Piro that was submitted to the Sunray Park racing office for the horse "Gallivant Ar". Jesus Antonio Apodaca-Diaz's brother, Daniel Apodaca, is listed as the owner of the horse "Gallivant Ar."

NMAC 16.47.1.8 (L)(1)(i) "Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule".

In accordance with Rule 15.2.1.9 (B)(21)(a)(b), Jesus Antonio Apodaca-Diaz is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Jesus Antonio Apodaca-Diaz are ineligible to be entered or start in any race in this jurisdiction, per Rule 15.2.1.9(B)(21)(c). NMSA 1978, Section 60-1A-4(A)(2) provides "The commission may exclude or compel the exclusion of a person from all horse racetracks who the commission deems detrimental to the best interests of horse racing".

The Summary Suspension is regarding the Quarter Horse "Ef Facile Dynasty" which had a United States Department of Agriculture (USDA) Equine Infectious Anemia positive test result and was ordered into quarantine by the New Mexico Livestock Board (NMLB). Edgar Facio Antunez failed to cooperate with the NMLB as the horse "Ef Facile Dynasty" was removed from quarantine without authorization from the NMLB.
