RE: 2025-RUI-37 - Case Continued

Trainer Jose R. Gonzalez Sr. having been properly noticed appeared before the Ruidoso Downs Board of Stewards, with interpreter Lindsay Gonzalez, for his summary suspension hearing on July 10, 2025 at 12:00 P.M. regarding a medication violation on May 23rd, 2025, for first place finisher "Tres Mas" from race 5 at Sunray Park.

Sample E573514 tested positive for the drug Albuterol (Class 3 Penalty A drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on June 26, 2025, reported the presence of Albuterol confirmed in urine.

Sample E573514 also tested positive for the drug 3-hydroxylidocaine (Class 2 Penalty B drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on June 26, 2025, reported the presence of 3-hydroxylidocaine confirmed in blood.

Martin Felix and Manuel Estrada were listed as the Owners of "Tres Mas" at the time of this race.

Jose R. Gonzalez, Sr. was listed as the Trainer of record for the horse "Tres Mas" at the time of this race.

Split sample rights were afforded to and requested by Jose R. Gonzalez Sr.

Jose R. Gonzalez Sr. remains summarily suspended pending the results of the split samples.

NMAC 16.47.1.8 (L)(1)(i) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense

NMAC 15.2.6.9 (C)(1)(4) Medication Restrictions; There is no permissible concentration of clenbuterol or albuterol that is allowed to appear in any official sample. This includes samples collected from Quarter Horses and Thoroughbreds.

NMAC 15.2.6.9 B. (1)(2) Penalty recommendations:

In accordance with 5.2.1.9 B. (21), Jose R. Gonzalez, Sr. remains excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Jose R. Gonzalez, Sr., are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 B.(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Jose R. Gonzalez, Sr. must be done in accordance with 15.2.6.9 A.(13)(a)(b)(c)(d) Medication and Prohibited Substances, 15.2.1.9 A.(3) (a-c) Due Process and Disciplinary Action.
