Trainer James Gonzalez III having been duly notified, waived a 10-day notice and formal hearing, appeared before the Ruidoso Downs Board of Stewards on July 4, 2025, for failure to bring his entry #2 "Fiona Is Toxic" to the paddock with proper equipment (flipping halter) for the 2nd race on June 29th, 2025 at Ruidoso Downs.

#### The Board of Stewards hereby issue the following penalty:

1. A fine of Two Hundred Fifty Dollars (\$250.00) which must be paid on or before July 18th, 2025. Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule NMAC 15.2.1.9 A(7)(f) all fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

Jockey Noe Garcia Jr. having been duly notified appeared before the Ruidoso Downs Board of Stewards on July 6, 2025, for excessive use of the crop, while aboard #7 "Special D" in Race 9 on July 5, 2025, at Ruidoso Downs.

The Board of Stewards hereby issue the following penalty:

A fine in the amount of Five Hundred Dollars. (\$500.00). This fine is to be paid on or before July 24, 2025, in accordance with NMAC 15.2.1.9 A. (7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

Owner/Trainer Steve J. Gomez is hereby summarily suspended, effective immediately, July 10 2025, pending the outcome of his summary suspension hearing scheduled for Tuesday July 15, 2025, at 10:00 A.M. in the office of the Board of Stewards at Ruidoso Downs Racetrack (100 Joe Welch Lane, Ruidoso, NM, 88346), per 15.2.1.9 A.(3)(c) Summary Suspension. The Summary Suspension is regarding a medication violation on June 22, 2025, for second place finisher "White Face Luck" from race 4 at Ruidoso Downs.

Sample E548571 tested positive for the drug Albuterol (Class 3 Penalty A drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on July 7, 2025, reported the presence of Albuterol confirmed in urine.

Steve J. Gomez, was listed as the Trainer of "White Face Luck" at the time of this race.

Humberto Balderrama was listed as the Owners of "White Face Luck" at the time of this race.

NMAC 16.47.1.8 (L)(1)(i) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule;

NMAC 15.2.6.9 (C)(1)(4) Medication Restrictions; There is no permissible concentration of clenbuterol or albuterol that is allowed to appear in any official sample. This includes samples collected from Quarter Horses and Thoroughbreds.

In accordance with 15.2.1.9 B. (21), Steve J. Gomez. is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Owner/Trainer Cristian Leonardo Alcala is hereby summarily suspended, effective immediately, July 23, 2025, pending the outcome of his summary suspension hearing scheduled for August 1, 2025, at 9:00 A.M. in the office of the Board of Stewards at The Downs at Albuquerque (145 Louisiana Boulevard NE, Albuquerque, NM 87108), per 15.2.1.9 A.(3)(a)(b)(c) Summary Suspension. The Summary Suspension is regarding conduct detrimental to the best interest of racing due to the condition of four horses, post-race from eleven starters, resulting in one deceased horse, and three that required emergency transportation by equine ambulance, one of which required admittance to a veterinary hospital at the 2025 Ruidoso Downs race meet.

The hearing will be held on Microsoft Teams Online at Meeting ID: 273 228 840 289 2 Passcode: MX9Le9Yi or you may choose to be present in person in The Downs at Albuquerque Board of Stewards' office.

The medical records of each horse that Cristian Alcala entered or raced at the 2025 Ruidoso meet are required to be submitted to the Stewards by the time of the scheduled Summary Suspension Hearing. See NMSA 1978, § 60-1A-4(A)(3) (Commission may compel production of documents).

NMAC 16.47.1.8 L.(1)(i)(o) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) Is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule; (o) Has engaged in conduct unbecoming or detrimental to the best interests of racing.

Practicing Veterinarian John Pickard having been duly notified, appeared via Microsoft Teams for his disciplinary hearing before the Ruidoso Downs Board of Stewards at 9:00 a.m. on July 10, 2025, regarding the administration of furosemide to the horse "Mozart J", the first-place finisher in race 6 on May 17, 2025, at Sunray Park. Mozart J tested positive for furosemide found in Sample E573488 confirmed in blood by Industrial Laboratories (The official Laboratory for the NMRC).

During testimony given by Practicing Veterinarian John Pickard he admitted to mistakenly administering furosemide to the horse "Mozart J" who was not registered as a Lasix user at the time of the race.

#### Licensee is found to be in violation of NMAC:

NMAC 15.2.6.8 (B)(7) Treatment Restrictions; Veterinarians shall not have contact with an entered horse on race day except for the administration of furosemide under the guidelines set forth in Subsection D of 15.2.6.9 NMAC unless approved by the official veterinarian or in an emergency situation. Should an emergency occur during evening hours, the veterinarian shall notify the official veterinarian as soon as possible the following morning.
