Practicing Veterinarian Dr. Morgan Selman, having been properly noticed appeared for her disciplinary hearing before the Ruidoso Downs @ D.A.A. Board of Stewards on August 12, 2025, at 9:30 A.M. regarding unauthorized administration of intravenous substances to three horses for trainer Marco Adair Chavez-Gutierrez with whom she did not have a valid veterinarian-client-patient relationship at the Downs at Albuquerque on July 25, 2025.

Licensee is found in violation of:

NMSA § Chapter 61-Professional and Occupational Licenses Article 14 - Veterinary Medicine 61-14-13 (22)

(22) has engaged in the practice of veterinary medicine on any animal or group of animals in the absence of a valid veterinarian-client-patient relationship.

NMAC 16.47.1.8 L. Grounds for Disciplinary Measures For a License, And Refusal, Denial, Suspension, or Revocation of a License.

- 1. A fine of Five Thousand Dollars (\$5,000.00) which must be paid on or before August 25, 2025, in accordance with NMAC 15.2.3.8 B. (3)(e). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to NMAC 15.2.1.9 (A)(7)(f) all fines imposed by the Stewards shall be paid to the Commission within 14 days after the Ruling is issued, unless otherwise ordered.
- 2. A ninety-day (90) suspension beginning August 12, 2025, through November 9, 2025 (inclusive).
- 3. Reimbursement in the amount of \$550.59 to the New Mexico Racing Commission for 3 out of competition tests.

Licensee is found to be in violation of NMAC:

16.47.1.8 L. Grounds for Disciplinary Measures for a License, And Refusal, Denial, Suspension, or Revocation of a License:

16.47.1.8 L. (i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule.

Aggravating factors:

Acting in a disrespectful and aggressive manner towards multiple Security Officers. Failure to produce his NMRC License when requested by Security Officers.

Jockey Carlos Antonio Guillen-Chacon having been properly noticed appeared with interpreter Andrea Diaz (sister) for his summary suspension hearing before the Ruidoso Downs at D.A.A. Board of Stewards on August 19, 2025, at 10:30 A.M. regarding his refusal to provide a urine sample at the direction of the NMRC Stewards.

After hearing the evidence and testimony presented, licensee is found to be in violation of NMAC:

16.47.1.17 HUMAN DRUG OR CONTROLLED SUBSTANCE AND ALCOHOL TESTING:

16.47.1.17. B. (6) refuses to submit to drug or controlled substances or alcohol testing, or both;

16.47.1.18 TESTING PROCEDURES

16.47.1.18 A. Controlled Substance and Drug Testing:

16.47.1.18 A. (1) At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the association grounds.

16.47.1.18 A. (2) All licensees may be subject to testing for controlled substances and drugs.

16.47.1.18 A. (3) No advance notice need be given.

16.47.1.18 A. (4) Refusing to test, failing to appear for a test, leaving before the test is over or otherwise failing to cooperate shall be considered a positive test. If this occurs during a race meet, the licensee is subject to and may be ejected from association grounds.

For this violation the Board of Stewards issue the following penalty:

Jockey Carlos Antonio Guillen-Chacon shall remain summarily suspended pending the outcome of his disciplinary hearing scheduled for August 29, 2025, at 9:00 A.M. in the offices of the Ruidoso Downs @ D.A.A.
