Trainer Ramon Mendoza having been duly notified, waived his 10-day notice and formal hearing before the Downs at Albuquerque Board of Stewards on September 7, 2025, for failure to notify the Stewards and have a Trainer Responsibility form on file, for his entry "Easy Perry Cartel" for race 5 on September 6, 2025. The Board of Stewards hereby issue the following penalty:

1. A fine of Three Thousand Dollars (\$3,000.00) which must be paid on or before October 4th, 2025. Failure to pay the fine within the prescribed time may result in immediate suspension. Jockey Brandon Guevara, having been properly summoned, appeared before the Downs at Albuquerque Board of Stewards on September 7, 2025, for careless riding and interference during the running of race 1 on September 6th, 2025, while aboard #9 "Patriots Fire", which veered in at the break interfering with #5 and #4, causing the #5 & #4 to take up sharply. "Patriots Fire" was disqualified from 3rd place and placed 9th.

Licensee is found in violation of NMAC:

15.2.5.13 E. (2)(a) Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit their mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13 E (3) Maintaining a straight course:

15.2.5.13 E. (3)(a) Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."

15.2.5.13 E. (3)(b) The offending horse may be disqualified, if in the opinion of the stewards, the foul altered the finish of the race, regardless of whether the foul was accidental, willful or the result of careless riding.

15.2.5.13 E. (3)(c) Post to Finish Which states in pertinent part that "If the Stewards determine the foul was intentional, or due to careless riding, they may fine or suspend the guilty jockey."

15.2.5.13 E. (3)(d) In a straightaway race, every horse must maintain position as nearly as possible in the lane in which it starts. If a horse is ridden, drifts or swerves out of its lane in such a manner that it interferes with, impedes or intimidates another horse, it is a foul and may result in the disqualification of the offending horse.
