Owner/Trainer Steve J. Gomez having been properly noticed appeared for his summary suspension hearing before the Ruidoso Downs Board of Stewards, via Microsoft Teams, on July 15, 2025 at 10:00 a.m. (Rule 15.2.1.9 A. (3)(a)(b)(c) Summary Suspension), regarding a medication violation on June 22, 2025, for second place finisher "White Face Luck" from race 4 at Ruidoso Downs.

Sample E548571 tested positive for the drug Albuterol (Class 3 Penalty A drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on July 7, 2025, reported the presence of Albuterol confirmed in urine.

Steve J. Gomez was listed as the Trainer of "White Face Luck" at the time of this race.

Humberto Balderrama was listed as the Owners of "White Face Luck" at the time of this race.

Split sample rights were afforded to Trainer Steve J. Gomez and accepted.

After hearing the testimony and evidence presented, the Ruidoso Downs Board of Stewards determined that Mr. Steve J. Gomez shall remain summarily suspended pending the outcome of the split sample results.

NMAC 16.47.1.8 (L)(1)(i) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule:
