Groom Alfonso Tafoya appeared for his Disciplinary Hearing before The Downs at Albuquerque Board of Stewards on October 12, 2025, regarding a confirmatory laboratory result from Cordant Health Solutions (New Mexico Racing Commission Human Drug Laboratory), for a confirmed positive drug test on September 10th, 2025. Mr. Tafoya waived his Summary Suspension Hearing and 10-day notice for his Disciplinary Hearing.

Aggravating Factors considered: Mr. Tafoya submitted to a follow up drug test on October 12, 2025, and tested positive for the same drugs previously confirmed by Cordant Health Solutions.

After viewing the evidence and hearing testimony presented, licensee is found to be in violation of:

16.47.1.17 HUMAN DRUG OR CONTROLLED SUBSTANCE AND ALCOHOL TESTING:

B. Restricted Activities: All licensees may be subject to testing for controlled substances, drugs and alcohol. It shall be a violation for a licensee to utilize their commission issued license if the licensee: (7) presently has drugs or controlled substances or alcohol in their body.

- (1) At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the association grounds.

- (7)(a) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.

- (b) Riders cannot use the crop more than three times in succession without giving the horse a chance to respond before using the crop again.

C. (12) Jockey requirements: A jockey's weight shall include their clothing, boots, saddle and its attachments and any other equipment except the whip, bridle, bit or reins, safety helmet, safety vest, blinkers, goggles and number cloth. Upon the stewards' approval, jockeys may be allowed up to three pounds more than published and announced weights to account for inclement weather clothing and equipment when weighing in.

E. Post to finish:

- (10) Returning after the finish.
- (a) After a race has been run, the jockey shall ride promptly to the finish line, dismount and report to the clerk of scales to be weighed in. Jockeys shall weigh in with all pieces of equipment with which they weighed out
- (b) If a jockey is prevented from riding to the finish line because of an accident or illness to the jockey or the horse, the jockey may walk or be transported to the scales, or may be excused from weighing in by the stewards.
- (12)(a) Weighing in. A jockey shall weigh in at no less than the same weight at which he or she weighed out, and if under that weight by more than two pounds and after consideration of mitigating circumstances by the board of stewards, his or her mount may be disqualified from any portion of the purse money.

Clerk of scales: which states in part "The clerk of scales shall: verify the presence of all jockeys in the jockeys' room at the appointed time; verify that all such jockeys have a current jockey's license issued by the commission; verify the correct weight of each jockey at the time of weighing out and weighing in and report any discrepancies to the stewards immediately; oversee the security of the jockeys' room including the conduct of the jockeys and their attendants; promptly report to the stewards any infraction of the rules with respect to weight, weighing, riding equipment or conduct;"

The Board of Stewards hereby issue the following penalty:

A fine of Five Hundred Dollars (\$500.00). This fine is to be paid on or before November 9, 2025, in accordance with NMAC 15.2.3.8 B. (3)(e). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to NMAC 15.2.1.9. A. (7)(f) all fines imposed by the Stewards shall be paid to the Commission within 14 days after the Ruling is issued, unless otherwise ordered.
