RE: 2025-DAA-43 - Modified Ruling

Trainer Alberto Amparan having been duly notified, waived his right to a 10-day notice and formal hearing before the Downs at Albuquerque Board of Stewards on October 8th, 2025, for failure to present the horse "Quite Lovely" in the paddock on October 5th, 2025, for Race 7 by the designated time, necessitating a late scratch and mutuel refunds.

Licensee is found to be in violation of NMAC:

15.2.4.8 C. (1) Claiming of Horses: Any horse entered in a claiming race that is not present in the paddock at least 10 minutes to post will be scratched

The Board of Stewards hereby issue the following penalty:

A fine of Five Hundred Fifty Dollars (\$500.00) which must be paid on or before October 24th, 2025, in accordance with NMAC 15.2.3.8 B. (3)(e). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to NMAC 15.2.1.9. A. (7)(f) all fines imposed by the Stewards shall be paid to the Commission within 14 days after the Ruling is issued, unless otherwise ordered.

The appeal must be received by noon at the main commission offices or with the Stewards who issued the ruling and must be accompanied by a fee in the amount of \$400.00 dollars. The fee must be in the form of a cashier's check or a money order. The last day to file is October 20, 2025.
