Request for Approval of Transfer	In-House Counsel Bustamante introduced Mr. Fred Heinrich, providing him the opportunity to speak regarding the Sunland purchase. Mr. Heinrich, representing Sunland Park Racetrack and Casino, thanked the Commissioners for convening the Special Meeting. Mr. Heinrich explained that Mr. Stan Fulton acquired Sunland Park in December 2000, and that the Fulton family has been involved in New Mexico racing and gaming for 25 years, positively impacting many lives. He noted that over the past couple of years, the process for the sale has been underway, and Mr. John Grant Lincoln, through his company Strategic Gaming, has emerged as the successful purchaser. Mr. Heinrich respectfully requested approval of the transaction. In-House Counsel Bustamante clarified that the race days were approved on July of 2025, and confirmed that there are no changes in the dates, a total of 55 days of live racing. Mr. Heinrich reiterated the timing of the transfer of the racing licenses at 9:59am, and Gaming Control Board issuing a new license at 10:00am.	
F. Ratification of Approval of Commission's Amended FY27 Budget	CFO Trujillo discussed the changes in the budget that were sent to her by the oversight agency, including to remove the 10% insurance increase. It is unknown as to what the increase will be, but the original 10% increase was a reduction of \$29,500 dollars from the Commission's request budget. As a result, the total FY27 agency request budget submitted to DFA on September 1 is now \$8,064,700.00 dollars.
