Trainer/Owner Julian Rey Honesto is hereby summarily suspended, effective immediately, November 22, 2025, pending the outcome of his summary suspension hearing scheduled for November 30, 2025, at 5:45 P.M. in the office of the Board of Stewards at Zia Park (3901 West Mullen Drive, Hobbs, NM 88240), per 15.2.1.9 A.(3)(a)(b)(c) Summary Suspension. The Summary Suspension is regarding a medication violation on November 2, 2025, for first place finisher "Easy Winner" from race 5 at Zia Park.

Sample E549239 tested positive for the drug Tulobuterol (Class 1 Penalty A drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on November 21, 2025, reported the presence of Tulobuterol confirmed in blood.

NMAC 16.47.1.8 (L)(1)(e)(i)(o) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

- (e) has been found in violation of rules governing racing in New Mexico and of other racing commissions or of any recognized regulatory organization:
- (i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule:
- (o) has engaged in conduct unbecoming or detrimental to the best interests of racing:

NMAC16.47.1.8 U. #### A . Penalties:

(1) In issuing penalties against individuals found guilty of medication and drug violations, a regulatory distinction shall be made between the detection of therapeutic medications used routinely to treat racehorses and those drugs that have no reason to be found at any concentration in the test sample on race day.

(2) The stewards or the commission will use the association of racing commissioner's international recommended penalty as a starting place in the penalty stage of the deliberations for a rule violation for any drug listed in the association of racing commissioners international uniform classification guidelines for foreign substances.

NMAC 15.2.6.9 B. Penalty Recommendations

- (b) The flap is the only allowable attachment to the shaft and must meet the following specifications. The length beyond the end of the shaft shall be a maximum of one inch with a minimum width of eight-one hundredths inch and a maximum of one and six-tenths inches. There shall be no reinforcements or additions beyond the end of the shaft. There shall be no binding within seven inches of the end of the shaft and the flap must include shock absorbing characteristics similar to those of the contact area of the shaft.

(e) A horse that has been placed on the steward's list for a positive test pursuant to Subsection C of 15.2.6.9 NMAC may only be removed if the criteria set forth in that subsection are met or in the event of a split sample result which does not confirm the official laboratory's original finding of a positive test.

In accordance with 15.2.1.9 B. (21), Michael Megariz, III is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Michael Megariz, III are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 B.(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Michael Megariz, III must be done in accordance with 15.2.6.9 A.(13)(a)(b)(c)(d) Medication and Prohibited Substances, 15.2.1.9 A.(8) Due Process and Disciplinary Action, and 16.47.1.10 D. (7) Assistant Trainers.

Trainer/Owner Michael Megariz, III, is hereby summarily suspended, effective immediately, December 13, 2025, pending the outcome of his summary suspension hearing scheduled December 19, 2025, at 9:00 A.M. in the office of the Board of Stewards at Sunland Park (1200 Futurity Dr, Sunland Park, NM 88063), per 15.2.1.9 A.(3)(a)(b)(c) Summary Suspension. The Summary Suspension is regarding a medication violation on November 30, 2025, for second place finisher "Stable Mascot" from race 7 at Zia Park.

Sample E549453 tested positive for the drug Albuterol (Class 3 Penalty A drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on December 12, 2025, reported Albuterol confirmed in Urine.

Michael Megariz, III was listed as the Trainer of record for the horse "Stable Mascot" on November 30, 2025.

Julio Caballero was listed as the Owner of record for the horse "Stable Mascot" on November 30, 2025.

NMAC 16.47.1.8 L. (1)(e)(i)(o) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

- (e) has been found in violation of rules governing racing in New Mexico and of other racing commissions or of any recognized regulatory organization:

NMAC 16.47.1.10 B. (1) Absolute Insurer "The trainer is the absolute insurer of the condition of horses entered in an official workout or race..."

NMAC 16.47.1.10 C. (5) Trainers: A trainer is responsible for:

(5) the proper identity, custody, care, health, condition, and safety of horses in their charge;

NMAC 15.2.6.9 C. (1) Medication Restrictions; A finding by the commission approved laboratory of a prohibited substance in an official post-race or out-of-competition sample of a horse is prima facie evidence that the prohibited substance was administered to the horse and, in the case of a post-race test, was present in the horse's body while it was participating in a race.

NMAC 15.2.6.9 C. (4) There is no permissible concentration of clenbuterol or albuterol that is allowed to appear in any official sample. This includes samples collected from Quarter Horses and Thoroughbreds.

NMAC 15.2.6.9 MEDICATIONS AND PROHIBITED SUBSTANCES: The classification guidelines contained within the "Uniform Classification Guidelines for Foreign Substances and Recommended Penalties and Model Rule", December 2024 version 18.1 and "Association of Racing Commissioners International Controlled Therapeutic Medication Schedule for Horses", version 4.2.1. - December, 2020 update are incorporated by reference.

A . Penalties:

(1) In issuing penalties against individuals found guilty of medication and drug violations, a regulatory distinction shall be made between the detection of therapeutic medications used routinely to treat racehorses and those drugs that have no reason to be found at any concentration in the test sample on race day.

(2) The stewards or the commission will use the association of racing commissioner's international recommended penalty as a starting place in the penalty stage of the deliberations for a rule violation for any drug listed in the association of racing commissioners international uniform classification guidelines for foreign substances.

NMAC 15.2.6.9 B. Penalty Recommendations

NMAC 15.2.6.9 C. (8) Any horse that is the subject of a positive test report from the official laboratory for a drug in one of the following categories shall be placed immediately on the steward's list: (a) any drug categorized by the association of racing commissioner's international "uniform classification guidelines for foreign substance and recommended penalties and model rule" incorporated by reference under 15.2.6.9 NMAC as a penalty class A substance;

A. The trainer is responsible for the condition of horses entered in an official workout or race and is responsible for the presence of any prohibited drug, medication or other substance, including permitted medication in excess of the maximum allowable level, in such horses. A positive test for a prohibited drug, medication or substance, including permitted medication in excess of the maximum allowable level, as reported by a commission- approved laboratory, is prima facie evidence of a violation of this rule. In the absence of substantial evidence to the contrary, the trainer is responsible.

B. A trainer shall prevent the administration of any drug or medication or other prohibited substance that may cause a violation of these rules.

E. Additionally, with respect to horses in their care or custody, the trainer is responsible for:

(1) the proper identity, custody, care, health, condition and safety of horses;

## NMAC 15.2.3.8. B. (9)(a)(e) Stewards List

(a) The stewards shall maintain a stewards' list of the horses which are ineligible to be entered in a race because of poor or inconsistent performance behavior on the racetrack that endangers the health or safety of other participants in racing or for positive tests pursuant to Subsection C of 15.2.6.9 NMAC.

Trainer Tammy Johnson having been properly noticed, appeared for her hearing before the Zia Park Board of Stewards (3901 West Millen Dr Hobbs NM 88240), on December 13, 2025 at 8:15 a.m., regarding disrespect to an Official Veterinarian when she was informed the horse "Big Daddy Dan" would need to have to work and a clear blood sample to have the horse removed from the Vet List.

Testimony provided by the New Mexico Racing Commission Official Veterinarian described Trainer Tammy Johnson's response as making comments to "kill her horse" when she was informed of the requirements for removal from the Veterinarian's List.

### After hearing the testimony and viewing the evidence presented, Licensee is found in violation of NMAC:

NMAC 16.47.1.8 L. (1)(e)(i)(o) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(e) has been found in violation of rules governing racing in New Mexico and of other racing

commissions or of any recognized regulatory organization:
