No technical information served as the basis for proposed rules.

Statutory Authority: Legal authority for NMRC rulemaking can be found at NMSA Section 60-1A-4(B)(1).

The following rule amendments are proposed:

Subsection D of 15.2.3.8 NMAC: The Rule deals with the Horsemen's Bookkeeper, an employee of the racetrack. The purpose of the proposed Rule change is to specify and broaden what can be properly paid with purse money.

Subsection A of 15.2.5.12 NMAC: The Rule deals with situations under which a horse is ineligible to enter in a race. The purpose of the proposed Rule change is to promote fairness by ensuring all time qualifiers for a race in fact receive a purse.

Subsection A of 15.2.5.13 NMAC: The purpose of the proposed Rule change is to correct a typographical error.
