Ruling:

Owner Rodolfo Gonzalez-Villar, having been properly noticed, failed to appear for his disciplinary hearing (which was held in absentia via Microsoft Teams) before the Sunland Park Board of Stewards on January 20, 2026 at 10:00am, regarding medication violations for "Meleros Cerveza", first place finisher of the fourth race on November 23, 2025 at Zia Park.

Rodolfo Gonzalez-Villar was listed as the Owner of record for the horse "Meleros Cerveza" on November 23, 2025.

Chris D. Marquez was listed as the Trainer of record for the horse "Meleros Cerveza" on November 23, 2025.

Sample E549388 tested positive for the drug Clenbuterol (Class 3 Penalty A drug) and the drug Ambroxol (Class 4 Penalty B drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) dated December 19, 2025, reported the presence of Clenbuterol confirmed in blood, and Ambroxol confirmed in urine.

Split sample rights were afforded to and declined by Trainer Chris D. Marquez and Owner Rodolfo Gonzalez-Villar, pursuant to Rule 15.2.6.10 D. (2).

At the hearing, no witnesses or evidence was presented to disprove the test results at issue or the resulting findings of the New Mexico Racing Commission.

After hearing testimony and viewing evidence presented, Owner Rodolfo Gonzalez-Villar is found to be in violation of NMAC Rules:

15.2.6.9 C. Medication Restrictions

15.2.6.9 C. (1) (4) There is no permissible concentration of clenbuterol or albuterol that is allowed to appear in any official sample. This includes samples collected from Quarter Horses and Thoroughbreds.

16.47.1.8 U. (1) Protection of Horses.

For this violation, (First offense within 365 days) the Board of Stewards hereby issue the following penalties:

1. Pursuant to Rule 15.2.5.13 E. (4)(d), "Meleros Cerveza" is disqualified and unplaced for all but pari-mutuel wagering purposes from the fourth race on November 23 2025, at Zia Park. Pursuant

(3).

In the event an appeal is pursued from this Ruling, the horse "Meleros Cerveza" shall remain on the Stewards' List until such time as the case is fully adjudicated.

Ruling:

Trainer Casey Lambert having been properly noticed, appeared before the Sunland Park Board of Stewards on January 13, 2026, for entering (and not withdrawing or scratching) the horse "Hold My Scotch" to race on December 16, 2025 at Zia Park, as "Hold My Scotch" was a pre-race veterinary scratch December 9, 2025.

Casey Lambert testified he entered "Hold My Scotch" the morning of December 9, 2025, to race December 16, 2025. Casey Lambert testified he was aware "Hold My Scotch" was a veterinary scratch from race 1 on December 9, 2025, as a result of the pre-race exam. Casey Lambert did not submit a scratch to the Stewards for race 9 on December 16, 2025.

Casey Lambert failed to conduct his business in the proper manner, by either submitting a timely scratch for a horse not in sound racing condition, or by following up with contacting the Stewards to address the situation with "Hold My Scotch" and clarify his veterinary status.

After hearing testimony presented, Licensee is found to be in violation of the following provisions of NMAC:

15.2.6.11 A. Trainer Responsibility

15.2.5.9 B.(6) Declarations and Scratches: Entry of any horse which has been scratched, or excused from starting by the stewards, because of a physical disability or sickness may not be accepted until the expiration of seven calendar days after such horse was scratched or excused and the horse has been removed from the veterinarian's list.

15.2.5.12 A.(3) B.(8) HORSES INELIGIBLE: A horse shall be ineligible to start when: it is not in sound racing condition;

The Board of Stewards hereby issue the following penalty:

Owner Jaime Tarango having been properly noticed, failed to appear for his disciplinary hearing via Microsoft Teams (held in absentia), before the Sunland Park Board of Stewards on January 27th, 2026, regarding a criminal felony charge for possession and falsification of his license application.

After hearing testimony and viewing evidence presented, the Board of Stewards determined that licensee is found to be in violation of NMAC:

16.47.1.8. L (1)(a)(d)(f)(i)(o) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license:

(1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(a) has been convicted of a felony;

(d) has failed to disclose or falsely states any information required in the application;

(f) has been found to have made false or misleading statements to the commission, stewards, or any racing official;

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule;

(o) has engaged in conduct unbecoming or detrimental to the best interests of racing.

NMSA 1978, 60-1A-11. A. B. C. Granting a license; standards; denial and revocation; suspension and penalties.

C. A person issued or applying for an occupational license who has positive test results for a controlled substance or who has been convicted of a violation of a federal or state controlled substance law shall be denied a license or shall be subject to revocation of an existing license unless sufficient evidence of rehabilitation is presented to the commission.

For these violations, the Board of Stewards hereby issue the following penalty:

1. Jaime Tarango's license issued by the New Mexico Racing Commission is hereby revoked.

Jockey Kevin Carmona, having been properly noticed, appeared with an Industry representative before the Sunland Park Board of Stewards, on January 23, 2026, for careless riding during the running of race 2 on January 19, 2026, while aboard #2 "Shame Them", for veering inward, causing interference with #1 "Rail Runner".

Licensee is found in violation of NMAC:

15.2.5.13 E. (2)(a) Post to Finish: A jockey shall not ride carelessly or willfully so as to permit their mount to interfere with, impede or intimidate any other horse in the race.

15.2.5.13 E. (2)(b) No jockey shall carelessly or willfully jostle, strike or touch another jockey or another jockey's horse or equipment. It shall be the discretion of the stewards to determine if the jostle, strike or touch had an effect on the outcome of the race and warrants a disqualification

15.2.5.13 E (3) Maintaining a straight course:

15.2.5.13 E. (3)(a) When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul.

15.2.5.13 E. (3)(b) The offending horse may be disqualified, if in the opinion of the stewards, the foul altered the finish of the race, regardless of whether the foul was accidental, willful or the result of careless riding.

15.2.5.13 E. (3)(c) If the Stewards determine the foul was intentional, or due to careless riding, they may fine or suspend the guilty jockey.

15.2.5.13 E. (3)(d) In a straightaway race, every horse must maintain position as nearly as possible in the lane in which it starts. If a horse is ridden, drifts or swerves out of its lane in such a manner that it interferes with, impedes or intimidates another horse, it is a foul and may result in the disqualification of the offending horse.

For this violation, the Board of Stewards issued the following penalty:

A 7-calendar day suspension, beginning on January 30, 2026, through February 5, 2026

Sample E655841 tested positive for the drug Albuterol (Class 3 Penalty A drug). An affidavit from Industrial Laboratories (the official laboratory for the New Mexico Racing Commission) on January 28, 2026, reported Albuterol confirmed in Urine.

Omar Acosta was listed as the Trainer of record for the horse "The Huerfanita" on January 9, 2026.
